Mayor Strickland called the meeting to order, and Councilman Adams opened with prayer followed by the Pledge of Allegiance.

**APRIL 4, 2022, Minutes** – Motion to approve by Councilman Thompson, seconded by Councilwoman Clements, Councilman Fowler opposed, Councilman Adams opposed stating he wanted City Clerk's exact words in Department Head Comments, and Mayor Strickland opposed.

- •Jesse McQuillan with Wiregrass Economic Development stated FEMA still has Covid money available. He will get information to the mayor.
- •Glenda Wright asked if Hartford has a leash law. Ms. Wright stated she lives at 218 Hillcrest Avenue, and she is tired of dogs, cats and goats coming on her property and hocken.

### **AGENDA:**

- 1. **DECLARE COUNCIL SEAT DISTRICT 4 VACANT** Councilman Fowler made a motion to declare District 4 seat vacant, which motion was seconded by Councilman Adams. Mayor Strickland abstained, Councilwoman Clements yea, Councilman Thompson yea, Councilman Fowler yea, and Councilman Adams yea. Motion carried.
- 2. TODD WALZ ENTECH Discussed the three proposals submitted for the purchase of hardware. Option one is hardware as a service, which is where we put in a server instead of the city buying it out right. This will be an extra charge on your monthly bill. If anything happens to the server, we need to upgrade, swap a drive, or add a drive, or any thing goes wrong we execute a warranty or upgrade, and it does not effect your monthly bill. We can add workstations as well with an additional monthly fee. Option two: buy the hardware out right. I have sent over Entech pricing for server, server storage, workstations, and monitors. Option three: bid hardware out. I emailed a spec list to the mayor, Vicky, and Attorney Hatcher.
- 3. RESOLUTION 04-18-22 SURPLUS PROPERTY Chief Ward recommended donating the two Crown Victoria's to City of Slocomb and taking sealed bids for the Ford F150. Mr. Hatcher stated it is legal to transfer between government entities. You will
